

CLT Guiding Principles

- 1) Accountability to community residents
- 2) Retention of public subsidy to benefit future families
- 3) Creation of permanent affordable housing
- 4) Protection of land from real estate speculation







- Supported by the **Chan Zuckerberg Initiative**
- Developed and conducted over 2021
- Survey team=CA CLT Network board & staff and Tim Thomas, Mona Al-Abadi, and Hannah Phalen

Offers insight into critical resident demographics












CA CLTs Primarily Serve Low-Income and BIPOC Populations

Annual Household Income of CLT Residents




80% of CLT residents are Black, Indigenous, and People of Color




CA CLTs are Providing Residents with Economic Security

60% Residents reported an increase in their family's economic security after moving to a CLT home




CLTs Currently Rely on Program Revenues & Local Government Subsidy




